



The Polish Institute and Sikorski Museum Fees and Charges

Archives

1. Access to archives for those carrying out their own research and making their own notes using paper and pencil, laptop or tablet is free, but customers are encouraged to make a voluntary donation, including signing a gift aid declaration if applicable. The customer receives 30 minutes free guidance by The Polish Institute and Sikorski Museum (PISM) archive staff on how to use the archives, catalogues, indices etc. Customers will select the material, which they wish to study and Archive staff will then facilitate access to the requested files (only a limited number at a time). Customers will generally receive the requested material in electronic format where available. Original material will only be used if digitalization has not yet occurred. If further detailed guidance and/or research are requested from PISM staff, a charge of £20 per hour or any part thereof, will be incurred. All charges, including copying, post and packaging etc to be paid before leaving the premises.
2. Research carried out solely by PISM staff - (requests received in any way e.g. by written correspondence: post, email) – £50, to a maximum of 2 hrs per enquiry, with no guarantee of success + postal and document copying charges (as detailed below). No work will be carried out without prior written agreement to cover indicated fees.
3. Certified copies of documents – appropriate document copying and postal charges plus £20 certification charge per page.
4. Monochrome photocopy - A4: £0.60 per page for first 250 and £0.55 per page for those above plus £15.00 per hour, or any part thereof, admin. fee. A3: £0.75 per page for first 250 and £0.70 per page for those above plus £15.00 per hour, or any part thereof, admin. fee.
5. Colour photocopy - A4: £1.20 per page for first 250 and £1.10 per page for those above plus £15.00 per hour, or any part thereof, admin. fee. A3 - £1.70 per page for first 250 and £1.60 for those above plus £15.00 per hour, or any part thereof, admin. fee.
6. Digital print (will include PISM watermark) of previously scanned document: A4 - £0.50 per page for first 250 and £0.45 per page for those above, plus £15.00 per hour, or any part thereof, admin fee.
7. Digital print (will include PISM watermark) of non-scanned document: A4: £0.50 per page for first 250 and £0.45 per page for those above, plus £25.00 per hour, or any part thereof, admin fee.
8. Digital copy (will include PISM watermark) onto own digital card, disc, memory stick etc. (only at discretion and with permission of staff) £0.50 per page for first 250 and £0.45 per page for those above plus £25 per hour, or any part thereof, admin charge.
9. Use of own camera, phone, tablet or other devices (only at discretion and with permission of staff - no flash, tripods or scanning permitted): £0.50 per exposure up to a maximum of 250 pages per day.
10. Customers to pay all post and packaging costs in addition to any fees/charges.
